divided the City of Costa Mesa into 124 individual grids. The grids split Census blocks and Census block Groups and even dissolve to census block groups together. The population numbers don't add up. There is no legal software or stats that is provided by the Census on population by base on Census Blocks. All stats are provided by Census Block Group.

A **Census Block Group** is a geographical unit used by the United States Census Bureau which is between the Census Tract and the Census Block. It is the smallest geographical unit for which the bureau publishes sample data, i.e. data which is only collected from a fraction of all households

This Redistricting is officially being done wrong and misleading to the public.

I am the creator of Draft Map 101. First of all, I want to mention that there is an error in the map I drew versus what is displayed on the website. I included Pop. Unit 98 in District 4, but on the website, it is still displayed as District 5. I have included a picture of my map below which shows Unit 98 in District 4.

That being said, I would like to submit a "fixed" version of my map (101A, if you will). Along with the change above of Pop Unit 98 (which was in the original), this new version would transfer Pop. Unit 123 from District 3 to District 6 to comply with the 10% rule. I would also like to make sure that the boundary for the proposed District 3 is the Golf Course and NOT Tanager Dr. All of the houses on Tanager, Canary, and Swan should be in District 1. I can't do that on the spreadsheet so I hope that can be fixed on your end.

Hello,

I am the creator of Public Map 101, so obviously, that is the one I support.

First, let me suggest a few changes that should be made to make it better. In District 5, the southern portion of Towne St. (Population Unit 98) should be included with District 4. This was in the original map that I drew during the community meeting.

In District 3, the block east of the 55 and south of 23rd (which I believe is Pop. Unit 123) should be converted to District 6. This would have the map follow the 10% rule. Also in D3, I would like to make sure that houses that abut the Golf Course are actually included in District 1, not District 3. The online map shows that boundary as Tanager Dr. and Swan Cir. when it should be the property line of the Golf Course and Fairview Park.

Next, I'd like to get into why I drew the map the way I did. I did not want to drastically change the current boundaries and so the districts are all roughly in the same area. There is also a minimal change to which areas will be changing election years.

In District 2, I wanted to put everything on the "other" side of the freeways into one district. This also creates a commercial/industrial hub district, with the two ends being industrial and the center being a commercial center of South Coast, Metro Pointe, the Camp, and the Lab. It is also deliberately under-populated to account for future housing developments in that area.

In District 3, I made the boundary Baker instead of the Paularino Channel since that made more sense. This district would be the "institutional" hub, with OCC, Vanguard, City Hall, NMUSD HQ, CMHS, the Fairgrounds, and green space such as (the eastern edge) of Fairview Park, the Golf Course, and TeWinkle Park. I also straightened the boundary with District 5 for clarity.

In Districts 4 and 5 I wanted to make the boundaries more clear and used major roads. I also put the area between Superior and Newport in D5 so that Newport could be a clear boundary between Districts 5 and 6.

Honorable Mayor and Costa Mesa City Council Members,

I'm sending this in case I can't come in person Tuesday. I studied the redistricting maps and find this issue very interesting. It is of critical importance to my neighborhood, Mesa Verde. As you probably all know, Mesa Verde is the name of the tract that is bordered by Fairview Park and the Costa Mesa Golf Course on the South, 405 Freeway on the North, Santa Ana river on the West, and Harbor Blvd on the East.

The area includes single family homes, apartments and condos, triplexes and duplexes.

This area has long identified itself as the Mesa Verde Community. Some of the entry points to parts of the neighborhood have signs identifying the area as Mesa Verde. On the south end, one is on Adams at what we call the "Lower Bird Streets". Another was facing Placentia, on the wall of an "Upper Birds" home backed up to Fairview Park. I say "was" because a drunk driver ran into it. We are trying to replace it. I say "we" because neighbors in the upper, lower and middle areas of Mesa Verde have taken an interest in trying to replace the sign, it's a sign of our neighborhood identity.

Also on Adams are a few same type signs welcome people to the middle section of Mesa Verde. On the North end of Mesa Verde, the same kind of sign is at Gisler and California Avenue, welcoming people to the uppermost parts of the neighborhood.

There is also a long-standing volunteer organization called Mesa Verde Community Inc. (MVCI) that has contributed to the sense of community this whole area enjoys. It has worked on many community projects over the years. I think it began in 1980 or so, and many residents from all parts of this neighborhood, top to bottom, have

been involved.

You can see this is a community with a strong identity. What I hope you will do is consider it as such, and keep all the borders of Mesa Verde within one district, so this cohesive community as a whole will have one representative on the City Council.

I have studied the maps. **Mesa Verde is a neighborhood with a longstanding strong identity, and it looks like the only map that keeps the whole neighborhood in one district is Map 103. I respectfully request you will select that map or create one that does preserve the WHOLE neighborhood in the same district.**
